College of Central Florida is a member of the Florida College System Activities Association and the National Junior College Athletic Association. All of the questions asked of you are required by these organizations as this information is required for eligibility purposes. In order for a student-athlete to be eligible to participate in sports at CF, he/she must meet the following standards as required by the FCSAA and the NJCAA:

- 1. Each student **MUST** enroll and earn at least 12 hours.
- 2. Each student **MUST** maintain a grade point average of 2.00 <u>each semester</u>. Your eligibility status depends upon your grade point average and hours earned each semester, so it is important to keep up your grades every term and maintain the hours and GPA (grade point average) as required in order to participate.
- 3. Each student **MUST** have a physical exam form signed by a physician which is kept on file in the Athletic Department.
- 4. Each student **MUST** sign a release form as required by the NJCAA. This authorizes the Athletic Department to check your files in Admissions and Records to obtain grades and information needed to submit to the national office for eligibility purposes. (Buckley Amendment Form)
- 5. It is the student's responsibility to keep your teachers **INFORMED** of your absences in class due to games, matches, and tournaments. Please notify your teachers **ahead of time** so that you can arrange to make up work or take a test early if need be. This will also show the teacher that you are aware of the importance of academics as well as athletics.
- 6. If you are ever in doubt of ANYTHING regarding classes, registration for classes, grades, whatever, please let us know either through your coach or come to the Athletic Department. We are here to help you as a student.
