**Dependents:** If you plan to apply for an F2 visa for spouse and/or child, \$5,000 for spouse and \$2,000 for each child must be added in the total estimated expenses. Photocopies of the passports for all dependents must be sent to CF at <a href="mailto:international@cf.edu">international@cf.edu</a>.

**Tuition:** The above amounts are estimates. Actual expenses may be higher. Tuition is calculated based on full-time enrollment (12 credits) in the fall and spring semesters. There will be additional cost per credit hour if you enroll for more courses beyond the minimum requirement. New students must pay tuition at orientation. F1 students are eligible for the tuition payment plan beginning their second semester of studies at CF but do not qualify for in-state tuition or federal financial aid.

Documents must be original or certified copy, dated less than six months from the date of application, officially translated into English, and issued by a financial institution or agency verifying access to the funds. #### **Documents Accepted:**

- Bank Documents For personal savings or support from family or sponsors, submit a bank letter on official letterhead containing the name of sponsor, relationship to the student, name of the student, and the U.S. dollar amount available for the purpose of the applicant's studies. Bank documentation must have bank information (address and phone number).
- Athletic Scholarship Attach a copy of your scholarship letter or Letter of Intent (LOI).
- Government or Agency Funding Attach a copy of your eligibility letter.

The following are examples of financial documents that are NOT accepted: real estate, salary statements, investment, stocks or other accounts in which money cannot be withdrawn.
