### JOB DESCRIPTION

JOB TITLE: DIRECTOR – ADMISSIONS AND STUDENT RECRUITMENT

PAY GRADE: A-1

OVERTIME STATUS: EXEMPT

### **MAJOR RESPONSIBILITIES:**

The Director – Admissions and Student Recruitment is responsible for the administration of all student recruitment functions, school and community relations, marketing/PR, prospect communication & tracking and reporting.

At the College of Central Florida, our vision is to be "Your first choice for quality higher education." We aim to accomplish this by providing a caring and exceptional learning environment that fosters the success of our students and community. Candidates considering becoming part of the CF family must be able to embrace and model this philosophy in their day-to-day responsibilities and demonstrate our standards: professional, responsive, informative, dependable and engaged.

#### PREREQUISITES FOR POSITION (Qualification Standards):

- 1. <u>Education or training</u>: Master's degree in higher education, student personnel, or a related area required.
- 2. Years of experience in the field: Four years' full-time experience in executive administration in a college setting required or four years' full-time higher education student recruitment experience at an executive level required. Two years' supervisory experience required. Two or more years' experience in college admissions, college recruiting, records and registration and/or student advising in a college student affairs department preferred.
- 3. Special skills or abilities related to the position: Organizational skills, communication skills, decision-making, customer service; working knowledge of basic rules, regulations, procedures related to admissions, residency, collegiate academy, dual enrollment, transcript evaluation, financial aid, records, VA, and registration. Computer literacy. Currency of knowledge related to college information disseminated to students. An understanding of the innovative uses of technology in the recruitment process.

#### **ESSENTIAL JOB FUNCTIONS:**

1. Plan, develop, and implement admissions, recruiting and marketing plans to meet college-wide enrollment goals.

### ESSENTIAL JOB FUNCTIONS (Continued):

- 2. Monitor special populations regarding admissions for international students, early admissions, etc.
- 3. Supervise, train and evaluate assigned staff.
- 4. Oversee daily operations of student recruitment.
- 5. Maintain all aspects of student recruitment budget (expenses and personnel).
- 6. Coordinate student recruitment services with other key college offices including marketing and public relations.
- Monitor the annual student recruitment cycle from point of inquiry through application and acceptance to the college to ensure a high level of customer service by making timely adjustments as required.
- 8. Regularly look for ways to provide more efficient customer service and accurate and consistent information to students.
- 9. Review and selection of all forms, brochures, and other informational materials designated for dissemination to students and the public.
- 10. Organize and conduct regularly scheduled staff training sessions.
- 11. Directly assist students as related to the function of recruitment/admissions.
- 12. Demonstrate leadership in coordinating all recruiting planning college-wide.
- 13. Develop and maintain close working relationships with key secondary schools and community constituents.
- 14. Analyze recruitment-related data and assess programming activities as part of the strategic enrollment planning.
- 15. Develop, maintain and execute the department's communication plan to prospective and admitted students.
- 16. Develop and monitor statistical reports to enhance recruitment strategies, yield management, forecasting and operational efficiency.
- 17. Make residency determinations based on district and state requirements
- 18. Oversee daily operations of Customer Service Center procedures and processes.
- 19. Supervise the functions of the collegiate academy and dual enrollment program as it relates to recruitment and admissions.
- 20. Assist in the annual development of articulation agreements and recruitment efforts between district public and private school systems, home-school parents, and the college.
- 21. Serve on the Dual Enrollment Exceptions Committee.

#### PHYSICAL DEMANDS:
