

BACHELOR OF SCIENCE IN NURSING DEGREE PROGRAM (RN-BSN)

Program Description

The Bachelor of Science in Nursing (BSN) program at the College of Central Florida is a limited-access program designed to allow associate degree registered nurses (RNs) to advance their education and facilitate entry into graduate nursing programs while supporting the Institute of Medicine's call to increase the proportion of nurses with baccalaureate degrees to 80 percent by 2020. While that number hasn't been met, steady progress is being made through programs like CF's RN-BSN. Gaining a BSN facilitates RNs achieving advanced clinical positions and nursing faculty positions, helping to meet additional needs for nurses in primary care, as well as nursing education.

CF's RN-BSN program coursework is completely online. While the program does not fully require simultaneous participation of students and instructors, there are some virtual synchronous days in some courses.

Students are expected to enter the program with sound computer knowledge and skills, including understanding the operating system Microsoft Windows, word processing, PowerPoint, use of a spreadsheet, internet browsers, literature search, sending and receiving email with attachments.

CF has an open door policy; however, the RN-BSN program is a limited-access program. Students must submit a separate application for this program. Applying to the College of Central Florida and to the RN-BSN program are two separate processes.

Admission Criteria for RN-BSN Program

- It is recommended that potential applicants attend an information session prior to submitting an application to the program. Review this information packet periodically to keep abreast of any potential revisions.
- Applicants must have a minimum 2.50 GPA for courses in general education and lower-division courses specific to the nursing program. Applicants must also have an all-college level GPA of 2.0 or higher. Students must receive a "C" or higher on all BSN program-specific required courses. If a student has attempted a required general education course previously, earning a W, D, or F, the course must be retaken and passed before that student can begin or continue taking BSN courses.
- All general education and lower-division course requirements must be completed, or currently enrolled in, when applying to the RN-BSN program. Applicants may apply for the program with two outstanding lower-division courses.

- Applicants must submit an active, unencumbered Florida RN license or have recently graduated from an accredited nursing program (ACEN or CCNE). Recent ADN graduates must attain an active, unencumbered Florida RN license prior to beginning a clinical rotation.
- Applicants must have an American Heart Association BLS or higher CPR certification.

RN-BSN Program Application Process

The RN-BSN Program is presently accepting students on a rolling basis. All applications submitted will be given equal consideration.

Application deadlines: Fall Semester, July 15; Spring Semester, Dec. 1; Summer Semester, April 15.

- 1. All applicants to the RN-BSN program must submit a College of Central Florida application and be accepted to CF as a student in good standing prior to applying to the program. This process is completed online; visit CF.edu/apply. Acceptance to the college does not guarantee acceptance into the program. The bachelor's degree application fee is \$30 for new CF applicants and previous CF students who have not applied to a bachelor's degree program.
- 2. Submit an official copy of your high school transcript and official copies of transcripts from any previous colleges or universities you have attended.
- 3. Contact the Academic Advising office at (352) 854-2322, ext.1489, to schedule an appointment with the RN-BSN advisor. The academic advisor will provide students with a form that must be attached to the RN-BSN application.
- 4. Submit the BSN application and all supporting documentation in person to Building 19 or online at https://cffoundation.wufoo.com/forms/bsn-application.*

 - Advising documentation:
 If you have attended a previous BSN program, please attach a letter from the nursing program director stating you are in good standing and eligible to return/re-enter.
 - c. Copy of current, unencumbered RN license <u>or</u> proof of nursing program completion.

*It is recommended that students make copies of the application and attachments for their records.

The selection process will be completed by an admission committee. Each application is reviewed to ensure that applicants meet minimum admission criteria and to calculate GPA. Once the RN-BSN application has been received the admission committee reviews the application, if the admission criteria are met, a letter of program acceptance will be sent.

Steps upon Acceptance into the BSN Program

- **Return the Acceptance Form** Return the form indicating acceptance or refusal of admission to the program to the Nursing Office by the date specified in the acceptance letter.
- Complete a Criminal Background Check Fingerprinting must be completed at CF, and instructions for initiating the background check will be included in the acceptance letter. The receipt given by CF after the background check is done must be submitted to Building 19, Room 111.

Arrest/Conviction Notice: Any applicant to the RN-BSN program who has been arrested or convicted of any offense other than a minor traffic violation should refer to Florida Statutes, Chapters 456 and 464, regarding licensure as a registered nurse. Individuals with a criminal history may not be eligible for admission to Health Sciences programs.

All students must begin with NUR 3825 and NUR 3846 and all students must end with NUR 4950.

It is strongly recommended that students take Statistics before NUR 4165.

NUR4165 should be taken before NUR 4776C.

Summer semester courses are condensed to 12 weeks versus 16 weeks (Spring and Fall).

Mini-mesters (denoted with *) are eight weeks (i.e., first mini-mester = first 8 weeks; second mini-mester = second 8 weeks). Mini-mesters are condensed to 6 weeks during the Summer semester.

Students are allowed to change their pathway once, during completion of the program. This is done by a formal petition filed with the nursing office.
