Full-time, Beginning April 22, 2024

TIMES: Class hours will be Monday – Friday 8:30 a.m.-5:30 p.m., and some Saturdays 8:30 a.m.-5:30 p.m. or 1:00 p.m-10:00 p.m. Consult with the academy coordinator for more details.

- 1. Go online to www.cf.edu/lawenforcement. In the blue sidebar, click Crossover from Correctional Officer to Law Enforcement Officer, C.T.C. Click Academy Application Packet. Please read all information in the application packet very carefully. **All** questions must be answered and can be filled in from the screen. If a question does not pertain to you then put N/A in the space. **Save and print the entire application.**
- 2. You must apply as a student with CF online and provide CF with sealed high school/college transcripts. The program code is **7247 Crossover to Law Enfr**.
- 3. Once you receive a student ID No. verifying admission to the college, you must complete the **Residency Affidavit** that is found on your portal (mycf.cf.edu) under the Admission Status tab.
- 4. The packet and college application must be completed (residency, transcripts, etc.) in its entirety **before** you call for a packet review. This includes all attachments:
 - Copy of high school diploma or equivalent
 - Current passport photograph
 - Copy of CJBAT (Law Enforcement) test scores (must be less than four years old)
 - Copy of birth certificate
 - Copy of FDLE Physician's form (CJSTC 75 must be done within six months of the start of the academy)
 - Copy of Social Security card
 - Copy of valid driver's license
 - Copy of DD214 (if applicable)
- 5. There are several forms in the application that must be notarized **before** your interview.
- 6. Once you have completed the packet and CF application, call the Criminal Justice Academy at **352-873-5838** to schedule your packet review.
- 7. During your packet review, you will receive information concerning your background investigation.

Important Dates to Remember

- Last day to schedule and receive a review is **Friday**, **April 5**, **2024**.
- Mandatory class orientation will be Wednesday, April 10, 2024, from 1-4 p.m.
- Class will begin Monday, April 22, 2024, at 8:30 a.m.
- Please wear casual business attire to the packet review and orientation. No jeans, shorts, or tank tops.
