



How to Designate Your Beneficiary

Use **one** of these three ways to designate the beneficiary or beneficiaries you want to receive your Investment Plan account balance upon your death:

- 1. Complete the online FRS Investment Plan Beneficiary Designation Form.
- 2. Download and complete the FRS Investment Plan Beneficiary Designation Form and mail or fax it to the Investment Plan Administrator:

 - By fax: 1-888-310-5559
- Log in to MyFRS.com and choose Investment Plan > choose your profile icon > select "Beneficiaries" from drop-down menu.
