PURPOSE

The College of Central Florida (CF) is seeking responses from qualified custodial service providers to ensure the cleanliness, sanitation, and maintenance of its facilities. This RFI is for informational purposes only and does not constitute a commitment to issue a request for bids/proposals, award a contract, or pay any costs incurred in the preparation of a response. Responding to this RFI does not guarantee selection in any subsequent procurement process.

BACKGROUND

CF operates multiple campuses across Marion, Citrus and Levy Counties. Sites include:

- Ocala Main Campus
- Wilton Simpson Citrus Campus
- Jack Wilkinson Levy Campus
- Hampton Center
- Vintage Farm Campus
- Appleton Museum of Art
- Airport Portable

These locations require comprehensive custodial services for classrooms, offices, restrooms, common areas, and special-use spaces. The College aims to gather information on service capabilities, industry best practices, and cost structures.

SERVICE REQUIREMENTS

Qualified vendors should be able to provide:

- General cleaning and sanitation
- Floor maintenance (sweeping, mopping, stripping, waxing, carpet cleaning)
- Restroom cleaning and restocking
- Trash collection and disposal
- Window cleaning
- Event setup and cleanup (as needed)
- Emergency cleaning response



FACILITY INFORMATION

CF operates on the following schedule:

- Classes: Monday–Friday, 7:00 AM to 10:30 PM
- Limited operations on Saturdays and Sundays for special events
- Seasonal breaks in **Spring** and **December**, with potential schedule adjustments

Vendors should submit information addressing:

- 1. Company background and experience in providing custodial services to educational institutions
- 2. Any federal, state, local, or cooperative purchasing contracts currently held (include contract numbers)
- 3. Scope of custodial services offered
- 4. Workforce capacity, including number of employees, training programs, and certifications
- 5. Environmental sustainability practices, including use of green cleaning products
- 6. Compliance with health and safety regulations
- 7. Quality assurance practices, including inspections, reporting, and customer feedback
- 8. Pricing models for various service levels and contract durations
- 9. Contact information for three references from educational institutions or similar public-sector clients
